Leveraging the potential for each person to break even, to quickly recoup their initial investment, is key.

By organizing and mastering some simple steps and tools within most people's reach, there is a **self-funding** aspect of this method of uniting with each other, towards a common cause.

We are essentially taking turns in playing the roles of prospects, then Candidates, then Benefactors, learning the essential components available in the information process, and supporting new prospects as they learn it, through our actions as we reach out to them.

The immediate challenge is in uniting each new group of prospects. They will behave like a disconnected hall full of cats, impossible to herd or organize, until their imagination is captured.

Otherwise they will not willingly agree to become Candidates, and follow suit,

Until they can be motivated to educate themselves, and see the value of the process of Paying it Forward, nothing can be accomplished.

The economic foundation relies completely on each person doing his or her part.

Each person doing their part ***must instead become its strength***, if the structure is to maintain integrity.
